Purchaser agrees not to sell or distribute said Compact Discs, DVD's, or MP3's to any other party. Purchaser agrees not to copy, duplicate, or digitally encode content to any other form or media.  
 4) Purchaser is properly licensed by ASCAP, BMI, SESAC and other similar entities to possess and publicly perform the music contained on the Compact Discs provided to Purchaser by RPM. In the event Purchaser performs the content on said CD's or DVD's in an unlicensed venue then this agreement shall immediately become null and void and RPM shall have no further obligation to provide any further service to Purchaser.
